# Stowford Parish Plan Questionnaire Community response report July 2017

The purpose of the questionnaire is to establish what the residents of Stowford Parish wanted for the future of the Parish and how they could see it being maintained and/or developed further.

Residents on the 2016 - 2017 West Devon Borough Council full register of electors list were individually posted the questionnaire on  $24^{th}$  April 2017. 24% of the residents have responded, making a total of 29 replies as of  $9^{th}$  July 2017. Not all respondents have replied to all the questions.

A list of five questions were presented for parishioners to answer anonymously.

The questions tabled were;

Question 1. Describe why living in Stowford is appealing for you?

Question 2. Looking to the future, would you see living in Stowford remaining a positive experience?

Question 3. What would you list as pressures in preserving Stowford as a flourishing place to live?

Question 4. The parish council is looking to the future of Stowford, would you list 3 priorities important to your family and neighbours?

Question 5. Would you like to help in the process of developing a Parish Plan for the future and how much time could you offer each month, this process may take up to 2 years?

Members of the public are encouraged to attend the meeting scheduled on 11<sup>th</sup> July at Stowford Parish Hall to openly discuss the findings and results from the questionnaire. Following this consultation, the council will finally consider all the issues raised by the questionnaire to determine if the inhabitants of the Parish wish to undergo a 'Parish Plan'.

Further consideration may be made from the questionnaire results, this to determine weather there are issues that have been raised for the council and West Devon Borough Council to address if possible.

A brief synopsis of the answers for each question has been provided by the Parish clerk.

#### Question 1.

#### Describe why living in Stowford is appealing for you?

#### **Answers**

- 1. Peace and quiet.
- 2. Very nice rural area of Devon, people very helpful and friendly.
- 3. I live in Portgate
- 4. Tranquil rurality, tucked away from main roads, but easily accessible trunk roads, a choice of 3 towns in easy reach for shopping and other essential and leisure amenities. Only 40 minutes from Exeter airport. Several possible urban areas for jobs in reasonable travelling distance.
- 5. Proximity to employment. Abundance of wildlife.
- 6. Local community, living amongst people that you have socialised with for years, access to good roads.
- 7. Living in Sprytown and surrounding valleys are generally unspoilt. Delightful rivers ambling from high Tors of Dartmoor down the Tamar. These upper tributaries remain the same for generations.
- 8. Open countryside, access to A30
- 9. It's quite, no main road and traffic, yet accessible.
- 10. In Stowford we are near to family and friends within Lifton, Lewdown & Launceston. Close to the A30 for travelling.
- 11. Quiet area, away from the buy towns and villages.
- 12. Its pieceful and rural, Very unspoilt and special.
- 13. It's got a strong community and offers good road connections. Lewdown & Lifton are either direction with good facilities.
- 14. Nice views, friendly community.
- 15. Privacy, safety, natural beauty, good dog walking and cycling routes, respectful neighbours.
- 16. It is a beautiful and relatively peaceful rural area.
- 17. Good access to A30 trunk route. Stunning landscape. Location between north and south coast. Close to Lewdown and Lifton. Sense of community.

#### Question 3.

#### What would you list as pressures in preserving Stowford as a flourishing place to live?

#### **Answers**

- 1. Increase in vehicles on our country roads.
- 2. Maintaining a mix of age groups in the village and engaging younger people in community life. Housing availability for young people at affordable prices. Post Offices at Lewdown and Lifton vital to community.
- 3. Lack of public transport, no village shop within walking distance, lack of affordable housing to purchase or rent.
- 4. Parking controls
- 5. Allowing local people to build/develop their own houses within the community that they already support. Encourage/support the younger generations to remain in the community.
- 6. Inappropriate pressures for large developments. Development of green energy- turbines/solar farms. Erosion of woodlands. Increased population. House prices too expensive for many young buyers.
- 7. House prices, poor public transport.
- 8. More affordable housing for young people to keep the village alive.
- 9. Further housing developments, conditions of roads.
- 10. I wouldn't want to see it change.
- 11. The use of homes/buildings for holiday accommodation instead of people who work locally.
- 12. Maintaining community buildings church/hall. Road maintenance for more rural properties. Mobile and broadband. Local amenities remain doctors in Lifton, shop in Lewdown.
- 13. Ongoing facilities shop, pub, Post Office, school and bus service. A need for social housing- all wards should be considered.
- 14. Not too sure.
- 15. We think it important to maintain and encourage residents to come together through well advertised functions which include all age groups. In Portgate we now suffer more heavy traffic due to new heavy machinery business in Allerford Farm. This has impacted on us!!
- 16. Bigger and larger traffic: ie, contractor at Allerford with larger swing-shovels.
- 17. A bus coming down into Stowford once a week, preferably Tuesdays, also the mobile library.
- 18. I'm not sure flourishing is appropriate, retaining its present image, not too much additional development, hanging on to its farming origins.
- 19. Keeping shop and Post Office and bus service.
- 20. A bus service once a week or fortnight to a town and back someday.
- 21. I think we all recognise the pressures on housing across the county for young couples and families. Perhaps those pressures aren't so great here in West Devon but we probably accept that there will be a need to build new properties. The issue will be where these new properties will be sited and the number that are built. The installation of a wind turbine in close proximity to the village was rejected at planning application last year but there is concern that similar such applications may be made in the future.

## The Parish council is looking to the future of Stowford, would you list 3 priorities important to your family and neighbours?

#### **Answers**

- 1. If there were a way of getting some kind of public transport i.e mini-bus or similar maybe twice a week, to drop down the hill, this would be a big help.
- 2. Broadband. Mobile phone signal. Country life.
- 3. We have only lived here 18 months so it is difficult to say. 1. Maintaining the rural character and historic aspect of the village 2. Keeping an active village hall and local schools. 3. Helping support sustainability of businesses internet links.
- 4. Maintain and strengthen community spirit, achieve a balanced age group. A small number of affordable housing.
- 5. Maintenance of roads and hedges.
- 6. Community spirit/ ethos. Supporting the next generation to stay within the community. Sympathetic growth/development.
- 7. Preservation of our natural beautiful environment. Encouraging the diversity and protection of woodlands, streams and green area's. Ensuring any future developments are in keeping.
- 8. 1. Public transport to Exeter/Plymouth. 2. Good internet access- currently average to poor.
- 9. No more wind turbines which spoil the area. More affordable housing for young people to keep the village alive. To keep the Lewdown shop.
- 10. Safe footpath/accessibility to walk to Lifton. To have more support for planning mainly WDBC, especially where longstanding residents and families of the community are concerned. Better public transport facilities. To re-open the Harris Arms as a public house.

Equally, the requirement for more holiday lets should also be considered a lower priority. (c.) The reason for the appearance of the village is mainly down to residents volunteering and giving up their own time for the sake of the community. Many new incomers to the area don't wish to get involved and therefore we risk losing the look and feel of the village. Any support the Parish council can give to help promote community coming together more would be a good thing.
